EHR 2015 Meaningful Use Hardship Exception – Apply by July 1

You can still apply for a 2015 EHR Meaningful Use Hardship Exception – it only takes a few minutes and helps even those physicians who do not have an EHR. CMS has indicated that they will be liberal in approving applications, saving practices \$8,000 or more by avoiding the 3% penalty in 2017. You must apply before July 1. Use application category 2.2.d. Contact us for the application.
